2. The source report should be of varied nature ie

- criminal intelligence
- L&O situation
- NDPS/Abkari etc.
- LWE
- Organized Crime
- Corruption at police stations
- Sand & soil mining
- Radicalization & ISIS/Communal harmony etc.
- Illegal custody/station mismanagement
- implementation of Janamythri beat system

Their assessment should be based on the source report. Those who are not active and who fail to give the report will be transferred.

3.Ensure that the field staff inform the details over phone to DPC directly before any other person informs the same.

4.Test checking of warrants returned should be done by SB field staff.

They should be the eyes and ears of the DPC on the field and should be proactive in nature.
